Introduction:

Security management fails quietly when guard posts, cameras, card readers and alarms are bought one at a time, never tied to a documented threat picture, and never tested against how an intruder would actually approach a site. Theft, unauthorised entry, sabotage and workplace violence then exploit the gaps between them. This Core Concept course gives security managers and supervisors a structured method to assess risk to people and physical assets, design layered protection, run guarding operations and measure performance. Each participant produces a Site Security Survey and Asset Protection Plan for a facility of their own.

Course Objectives:

- Conduct a security risk assessment that rates threat, vulnerability and consequence for the critical assets of a site using ISO 31000 principles
- Draft a security policy, organisation chart and post orders that define who protects what, when and how
- Design layered physical protection using the deter, detect, delay and respond model and CPTED principles
- Specify access control, CCTV and intrusion detection so that they operate as one integrated security system monitored from a control room
- Manage in-house and contracted guard forces through post orders, patrol plans, supervision checks and service level agreements
- Plan security incident reporting, internal investigations and security KPIs, and audit the security programme against its own policy

Target Audience:

- Managers responsible for the security function of a corporate campus, plant, hospital, hotel or retail estate
 - Supervisors who lead guard shifts, control room operators and patrol teams
 - Facility and property managers accountable for perimeter, building access and asset loss
 - Contract managers who oversee outsourced security providers and their service levels
 - Project and engineering leads who specify and commission electronic security systems
 - Loss prevention and asset protection leads who investigate theft, fraud and shrinkage on site

Conclusion:

Physical security works when people, procedures and technology are designed together around a clear view of what needs protecting and from whom. The course moves from asset and threat assessment through policy, CPTED and layered protection, to access control, CCTV and intrusion detection working as one integrated system, then to guarding, contracted security, investigations and critical facility protection. The final day applies it all in inspection walkthroughs and produces a Site Security Survey and Asset Protection Plan, with KPIs and an audit checklist to keep it under review.
