## Loading Master and Marine Terminal Operations: Ship/Shore Interface and Cargo Transfer

### Introduction:

Loading master errors at a marine terminal rarely stay small: a missed checklist item, an unagreed flow rate, a loose mooring or an unbonded hose can turn a routine cargo transfer into a spill, a fire or a quantity claim. This Core Concept course prepares loading masters and jetty supervisors to run the ship/shore interface on oil, gas and petrochemical berths, from pre-transfer conference through loading, ullaging, sampling and emergency release to cargo documents. Participants build a Jetty Cargo Transfer Control Pack for a berth from their own terminal.

### Course Objectives:

- Conduct a pre-transfer conference and complete the ship-shore safety checklist with the vessel's responsible officer
- Inspect mooring arrangements, marine loading arms and cargo hoses before connection and during the transfer
- Agree and monitor a cargo transfer plan covering sequence, flow rates, topping off and stoppages
- Verify ullage, temperature and sample records and follow the cargo quantity calculation at overview level
- Apply vapour control, static electricity precautions, emergency shutdown and emergency release procedures on the jetty
- Prepare transfer documentation, notices and letters of protest that support the terminal in cargo disputes

### Target Audience:

- Staff who supervise liquid bulk cargo transfers between tankers and shore on terminal jetties
  - Terminal operators who line up shore tanks, pumps and pipelines for loading and discharging
  - Marine and jetty supervisors responsible for berthing, mooring and connection of cargo equipment
  - Terminal HSE and emergency response staff who cover spill, fire and release scenarios on berths
  - Cargo inspectors and operations coordinators who handle ullage, sampling and shipping documents

- Cargo Sampling Points, Sample Labelling and Retention Records
- Vessel Experience Factor and Ship-Shore Quantity Difference at Overview
- Vapour Return Lines, Inert Gas and Static Electricity Bonding Precautions
- Emergency Shutdown Sequence and Emergency Release System Activation

### **Day 5: Jetty Walkthrough, Documentation and the Control Pack**

## **Why Attend This Course:**

- Return with a Jetty Cargo Transfer Control Pack prepared for a berth at your own terminal
- Lead the ship/shore interface with vessel officers using one agreed checklist, stop signals and rate plan
- Spot mooring, arm, hose and bonding defects on the berth before they stop a transfer or cause a release
- Protect the terminal in quantity and demurrage discussions with complete time sheets, records and letters of protest

## **Conclusion:**

Safe and accurate cargo transfer depends on the loading master holding the ship/shore interface together from arrival to departure. The course moves from terminal and berth layout and the loading master role, through ISGOTT, the pre-transfer conference and the safety checklist, to mooring, loading arms, hoses and the transfer plan, then to ullage, sampling, vapour, static and emergency release risk. The final day applies a berth walkthrough and produces a Jetty Cargo Transfer Control Pack for use on the next vessel call.
