Introduction:

In the healthcare supply chain a missing catheter, an expired vaccine or a delayed infusion pump reaches the patient, not just the budget. Hospitals still buy by habit, carry duplicate products chosen by individual clinicians, lose stock to expiry on the wards and discover shortages when a theatre list is already running. This Core Concept course gives procurement, pharmacy and materials staff the methods to forecast, standardise, tender, store and track medicines, consumables and equipment. Working on hospital cases, participants build a Hospital Supply Assurance Plan for a product family in their own facility.

Course Objectives:

- Map the flow of medicines, consumables and medical devices from manufacturer to point of care and locate where cost, delay and waste enter it
- Forecast demand for medicines and clinical consumables using consumption and morbidity methods and set ward par levels from the results
- Run product standardisation and formulary reviews with clinicians through a value analysis process backed by evidence and total cost
- Prepare specifications, tender documents and evaluation criteria for medical devices and pharmaceuticals that balance clinical, technical and commercial factors
- Control cold chain storage, expiry, recalls and shortages with written procedures and records that follow good storage and distribution practices
- Measure supplier and supply chain performance with healthcare KPIs and assemble a Hospital Supply Assurance Plan for a product family

- Procurement staff who buy medicines, medical consumables and medical devices for hospitals and clinics
 - Pharmacy staff who manage medicine ordering, storage, formulary lists and distribution to wards
 - Materials management and medical stores staff who run receiving, storage, ward top-up and issues
 - Biomedical and clinical engineering staff who take part in equipment purchasing and asset records
 - Contract and supplier coordinators who monitor delivery, quality complaints and supplier scorecards for healthcare products

Conclusion:

Patients depend on the right medicine, device or consumable being available, in date and at the correct temperature when care is given. The course moves from the structure and cost of the healthcare supply chain, through forecasting, formulary and value analysis, to tendering for devices and pharmaceuticals, equipment life-cycle, cold chain, par levels, expiry, recalls and shortages. The final day applies this to hospital cases and produces a Hospital Supply Assurance Plan ready for review by pharmacy, procurement and clinical leads.
