Introduction:

Dangerous goods transport breaks down when a consignment is declared under the wrong UN number, packed in an unapproved packaging, labelled inconsistently or loaded next to an incompatible cargo, and the result is rejected bookings, held containers, fines and fires at sea. This Core Concept course trains shippers, freight forwarders, terminal and warehouse staff to apply the IMDG Code from classification through packing, marking, documentation, segregation and stowage. Working on real consignment files, each participant builds a Dangerous Goods Consignment Control File for a hazardous product their organisation ships.

Course Objectives:

- Classify a substance or article into the correct UN hazard class, division and packing group and select its UN number and proper shipping name from the Dangerous Goods List
- Navigate the seven parts of the IMDG Code and read the Dangerous Goods List columns, special provisions and packing instructions for a given entry
- Select UN-specification packagings, IBCs and portable tanks and apply the required marks, labels and placards to packages and cargo transport units
- Prepare a dangerous goods transport document and a container or vehicle packing certificate that pass carrier and terminal acceptance checks
- Apply segregation and stowage requirements, limited and excepted quantity provisions, and safe handling and storage practice in terminals and warehouses
- Compare sea requirements with road carriage under ADR and air carriage under the IATA DGR and assign duties across consignor, forwarder, carrier and terminal

Target Audience:

- Staff responsible for classifying hazardous products and issuing dangerous goods declarations at manufacturers, traders and distributors
 - Staff responsible for booking, checking and routing dangerous goods shipments at freight forwarders and shipping agents
 - Staff responsible for accepting, gating and positioning dangerous goods containers in marine terminals and inland depots
 - Staff responsible for packing, loading and securing dangerous goods into containers and vehicles
 - Staff responsible for receiving, segregating and storing hazardous materials in logistics warehouses
 - Staff responsible for emergency preparedness and incident reporting for hazardous cargo operations

Conclusion:

A dangerous goods consignment moves safely only when classification, packaging, hazard communication, documents and segregation all agree. The week moves from UN classification and duty holders, through the IMDG Code structure, the Dangerous Goods List and packaging rules, to marking, labelling, placarding and transport documents. It then covers segregation, stowage, limited and excepted quantities, terminal and warehouse handling and emergency response, and closes with ADR and IATA DGR comparison, consignment case work and a Dangerous Goods Consignment Control File for each participant.
