Introduction:

Legal translation errors between Arabic and English rarely look dramatic on the page, yet a shifted condition, an inconsistent defined term or an unchecked machine output can change who must do what and when. This Core Concept course builds a repeatable legal translation workflow for contracts, legislation and official documents, from source analysis and terminology equivalence to termbases, machine translation post-editing and structured revision. Participants work on authentic document types and leave with a Legal Translation Quality Pack: a bilingual termbase, a house style sheet and a quality assurance checklist.

Course Objectives:

- Analyse a legal source text for its legal system, function and status as an authentic or convenience translation before translating it
- Select full, partial or descriptive equivalents for legal terms that have no direct counterpart in the other legal system
- Translate contract clauses, defined terms, contractual duties and conditions between Arabic and English without altering their legal effect
- Translate articles of legislation, regulations and official documents while preserving numbering, cross-references and register
- Post-edit machine translation and large language model output of legal text to a full human post-editing standard
- Run a documented revision and quality check using an error typology, a termbase and a confidentiality routine

Target Audience:

- Translators responsible for rendering contracts, regulations and official papers between Arabic and English
 - Legal staff responsible for checking bilingual versions of agreements and filings before signature or submission
 - Government and corporate language units responsible for translating circulars, decisions and official correspondence
 - Revisers and reviewers responsible for second-person checking of translated legal documents
 - Terminology and localisation staff responsible for glossaries, termbases and translation memories

Conclusion:

Reliable legal translation between Arabic and English depends on a controlled process, not on fluency alone. The five days move from legal systems and terminology equivalence, through translation standards, termbases and translation memories, to translating contracts, legislation and official documents, and then to register, machine translation post-editing, error-based quality checks and confidentiality. The final day applies this workflow in a case lab and closes with a Legal Translation Quality Pack that participants reuse across their legal translation work.
