Introduction:

Supply chain security management often stops at the warehouse fence, while cargo is stolen, tampered with or used to smuggle contraband at handover points, in transit and through partners nobody vetted. This Core Concept course gives logistics, security and customs compliance managers a working method to assess threats across nodes and routes, apply an ISO 28000 security management system, protect containers and seals, track shipments and screen partners and personnel against Authorized Economic Operator security criteria. Participants produce a Cargo Security Plan and AEO Security Readiness Self-Assessment for their own operation.

Course Objectives:

- Map the cargo threats of theft, pilferage, tampering, smuggling and terrorism to each node, handover point and transport leg of an operation
- Set up and maintain an ISO 28000 security management system with a security policy, objectives, operational controls and performance evaluation
- Assess the security criteria that customs administrations apply to Authorized Economic Operators under the WCO SAFE Framework and close the gaps found
- Specify container and seal integrity checks, cargo tracking and in-transit controls for road, sea and air shipments
- Vet business partners, carriers and personnel against documented security requirements and keep evidence for audits
- Run supply chain security audits, report and investigate cargo security incidents and feed corrective actions back into the security plan

Target Audience:

- Managers responsible for warehouse, distribution centre and cross-dock operations where cargo is received, stored and dispatched
 - Managers responsible for transport, freight forwarding and carrier operations that move cargo between nodes
 - Security managers responsible for protecting cargo, logistics facilities and the people who handle goods
 - Customs compliance managers responsible for trade security partnerships and authorised operator status
 - Procurement and supplier managers responsible for onboarding and monitoring logistics service providers
 - Quality, audit and risk managers responsible for management system audits across logistics operations

Conclusion:

Cargo stays secure when every node, route, partner and person in the chain works to the same documented controls. The course moves from the cargo threat picture through the ISO 28000 security management system and AEO criteria under the WCO SAFE Framework, to facility, container, seal and tracking controls, then to partner vetting, personnel and information security, audits and incident response. The final day applies these methods to case studies and closes with a Cargo Security Plan and AEO Security Readiness Self-Assessment ready for internal review.
