## Crime Scene Management: Scene Security, Evidence Recovery and Chain of Custody

### Introduction:

Crime scene management decides whether physical evidence survives to court. Cases fail when cordons are set too small, scene logs have gaps, items are packed in the wrong container or a transfer between custodians goes unrecorded. Investigators and scene staff must secure, record, search and recover in the right order, then prove continuity for every exhibit. This Core Concept course builds that practice through a staged mock scene simulation, from first attendance to courtroom testimony. Participants produce a Crime Scene Management Plan and Exhibit Continuity Log for their own unit.

### Course Objectives:

- Carry out first-responder duties at a scene, including preserving life, identifying the scene boundary and opening a scene attendance log
- Assess a scene and set inner and outer cordons, common approach paths and access controls that limit contamination
- Record a scene through notes, photography and measured sketches that another examiner can follow and reproduce
- Select and run a search method suited to the scene, then recover, package and label physical, trace and biological items to protect their integrity
- Maintain an unbroken chain of custody from recovery through storage, laboratory submission and return, and coordinate scene work with forensic laboratories and partner agencies
- Write a scene statement and present scene evidence under questioning, using a Crime Scene Management Plan and Exhibit Continuity Log

### Target Audience:

- Police investigators responsible for attending scenes and building the evidential case file
  - Crime scene officers responsible for recording scenes and recovering exhibits
  - Security and loss investigators responsible for protecting incident sites until handover
  - Forensic liaison staff responsible for laboratory submissions and exhibit tracking
  - Exhibits and property store staff responsible for evidence storage, movement and disposal records

- Evidence Integrity Failures: Broken Seals, Unrecorded Transfers and Storage Lapses
- Forensic Laboratory Submission Form and Examination Request Priorities
- Major-Incident Scene Management: Multiple Scenes, Rendezvous Points and Handover
- Multi-Agency Scene Coordination and Shared Exhibit Protocols

## **Conclusion:**

Physical evidence carries weight only when the scene was protected, recorded and searched in order and each exhibit can be traced from recovery to the witness box. The five days move from first response and scene roles, through cordons, documentation and search, to packaging, continuity, laboratory work and complex multi-agency scenes. The final day runs a timed mock scene and courtroom rehearsal and closes with a Crime Scene Management Plan and Exhibit Continuity Log ready for use at work.
