Healthcare Waste Management: Colour Coding, Sharps Safety and Collector Oversight

Introduction:

Healthcare waste management fails at the bedside long before it fails at the gate: needles pushed into black bags, overfilled sharps boxes, unlocked holding rooms and collector paperwork nobody reconciles. Porters, cleaners and nurses then face needlestick injuries and blood-borne infection, while ordinary refuse mixed with clinical discards inflates destruction costs. This Core Concept course trains hospital and clinic practitioners to sort medical discards by WHO class, colour code bins, route trolleys, run holding rooms, compare autoclave, microwave and incinerator options and audit collectors. Participants produce a Facility Healthcare Waste Management Plan.

Course Objectives:

- Categorise hospital discards using WHO healthcare waste classes and measure kilograms per bed-day by ward, theatre and laboratory
- Configure colour-coded bins, sharps boxes and biohazard labelling at bedsides, treatment rooms, pharmacies and laboratories
- Schedule porter collection rounds, trolley routes and holding room controls that keep clinical bags secure until collector handover
- Protect porters and cleaners with task-based PPE, needlestick first aid, post-exposure referral and hepatitis B vaccination records
- Compare autoclave, microwave, incinerator and disinfectant-based decontamination and verify collectors through consignment notes and destruction certificates
- Track performance with bin audits, KPIs and staff training records and compile a Facility Healthcare Waste Management Plan

Target Audience:

- Environmental services functions whose porters and cleaners collect and move clinical bags across wards and theatres
 - Infection prevention functions that write colour-coding rules and investigate needlestick injuries among support staff
 - Facility and support services functions responsible for holding rooms, trolleys and contracts with external collectors
 - HSE functions accountable for porter safety, breakage and leak incidents and injury reporting in hospitals and clinics
 - Nursing unit, theatre, laboratory and pharmacy supervisors who control bin use where discards arise
 - Clinic, dental and day-surgery operations functions that arrange small-volume collections with external providers

Day 1: WHO Healthcare Waste Classes and the Hospital Baseline

- WHO Healthcare Waste Classes: General, Infectious, Sharps, Pathological, Pharmaceutical, Cytotoxic, Chemical and Radioactive at Overview

- Needlestick First Aid, Post-Exposure Prophylaxis Referral and Hepatitis B Vaccination Register
- Breakage and Leak Kits for Body Fluids, Cytotoxic Drugs and Mercury Thermometers

Day 4: Decontamination Technologies and Collector Oversight

- Autoclave and Steam Units with Internal Mixing: Cycle Validation and Biological Indicator Tests
- Microwave Units and Disinfectant-Based Systems: Shredding, Contact Time and Residue Handling
- Incinerators for Pathological and Pharmaceutical Discards: Operating Temperature, Flue Gas Cleaning and Ash
- Collector and Decontamination Plant Due Diligence Checklist and Audit Visit Criteria
- Consignment Note Reconciliation Against Weighbridge Tickets and Destruction Certificates

Day 5: Ward-to-Gate Walkthroughs and the Facility Plan

- General Hospital Walkthrough: Ward Bins, Sharps Stations and Dirty Utility Rooms
 - Laboratory and Outpatient Clinic Walkthrough: Cultures, Specimen Containers and Small-Volume Holding

- Compare practice with peers from public hospitals, private clinics, laboratories and long-term care homes

Conclusion:

Safe handling of medical discards depends on the same small choices repeated at every bedside, trolley and holding room. The course moves from WHO classes and bag weighing audits, through colour coding, sharps boxes and labelling, to porter rounds, holding rooms, handler protection and leak kits, then to autoclave, microwave, incinerator and disinfectant options and collector paperwork. The final day applies ward-to-gate walkthroughs and turns the findings into a Facility Healthcare Waste Management Plan for the hospital waste committee.
