Intangible Cultural Heritage Safeguarding: Inventorying, Documentation and Transmission

Introduction:

Intangible cultural heritage disappears quietly: a last master weaver stops teaching, festival songs survive only on one elder's memory, and well-meant promotion turns a ritual into a stage act that its bearers no longer recognise. Heritage bodies often respond with scattered recordings that no community approved and no plan follows. This Core Concept course gives heritage authority staff, cultural NGOs and researchers a working method for safeguarding living heritage, from community consent and fieldwork inventorying to transmission and responsible promotion. Participants produce an Inventory Entry and Safeguarding Plan for one element.

Course Objectives:

- Identify living heritage elements across the five UNESCO domains and assess their viability and the threats to their transmission
- Explain the UNESCO Convention for the Safeguarding of the Intangible Cultural Heritage and the purpose of its lists and register when advising on nominations
- Obtain and record community consent and agree roles with practitioners, bearers and custodians before any documentation begins
- Conduct inventorying fieldwork using structured interviews, audio-visual recording and consistent metadata for every recorded item
- Design safeguarding measures for transmission through apprenticeships, formal and non-formal education and accessible digital archives
- Judge tourism and creative industry proposals for decontextualisation, over-commercialisation and misappropriation risks to an element

Target Audience:

- Heritage authority functions responsible for national or local inventories of living traditions
 - Cultural NGO functions that run community programmes for crafts, music, oral traditions and festivals
 - Research and documentation functions in universities and cultural centres that record practitioners in the field
 - Archive and library functions that store and give access to audio-visual heritage recordings
 - Culture policy and planning functions that prepare safeguarding strategies and nomination files
 - Cultural programming functions that link heritage bearers with education, tourism and creative sector partners

Conclusion:

Living heritage survives only while people keep practising and teaching it, so safeguarding work has to start and end with its bearers. The five days move from the five domains and viability, through the Convention, its lists and community consent, to interviews, audio-visual recording and metadata, then to apprenticeships, education, digital archiving and the risks of tourism and commercial use. The final day applies two element case studies and closes with an Inventory Entry and Safeguarding Plan reviewed by peers.
