Introduction

Digital transformation programmes often begin as a collection of disconnected technology projects, each justified on its own and none tied to a clear target state. Budgets are committed, platforms are bought, and the enterprise still works in the old way. This Core Concept course gives transformation managers a structured method to translate strategy into capability gaps, prioritise a portfolio of initiatives and sequence them into an executable roadmap with governance attached. Participants apply each tool to cross-sector cases and leave with an Enterprise Digital Transformation Roadmap for their own organisation.

Course Objectives

- Define a digital vision and target operating model that link business strategy to required capabilities
- Map current and target capabilities using TOGAF capability-based planning and ArchiMate views
- Prioritise transformation initiatives with weighted scoring, dependency analysis and Three Horizons balance
- Sequence initiatives into transition architectures and a wave-based roadmap with funding gates
- Establish transformation governance, OKRs and benefits tracking aligned to ISO/IEC 38500 and COBIT
- Produce an Enterprise Digital Transformation Roadmap ready for executive approval
