Introduction

Organisations face rising expectations from customers, investors and communities to control pollution, resource use and climate-related risk, and the 2026 revision of ISO 14001 raises the bar on context, life cycle thinking and change control. Many environmental management systems exist mainly on paper, with aspect registers that miss real site activities and audits that find little. This Core Concept course equips managers to implement an environmental management system that works in practice, from gap assessment to operational control and management review. Participants apply each requirement through a guided walkthrough and leave with an EMS Implementation Plan.

Course Objectives

- Assess current environmental practice against ISO 14001:2026 and define the scope of the environmental management system
- Identify environmental aspects, compliance obligations, risks and opportunities, and evaluate their significance
- Set an environmental policy, objectives and action plans that leadership can own
- Establish operational controls, emergency preparedness, competence and documented information for significant aspects
- Evaluate environmental performance and compliance, and run internal audits and management reviews that drive improvement
- Produce an EMS Implementation Plan built on a significant environmental aspects register

Conclusion

An environmental management system earns its place when it changes how sites operate, not when it produces documents. This course moves from the context and structure of ISO 14001:2026, through aspects, compliance obligations and planning, to the operational controls, indicators, audits and reviews that keep the system effective. The final day applies these requirements in a guided walkthrough and turns the findings into an EMS Implementation Plan that participants take back to their organisation, ready to guide the next stage of implementation.
