Introduction

Grant funding brings conditions that many organisations underestimate: eligible cost rules, reporting deadlines, results frameworks, procurement and audit requirements, and donor rights to reclaim money that is not properly spent. Late or weak reports, disallowed costs and unprepared audits damage donor relationships and future funding. This course from Core Concept equips managers to run the full grant lifecycle to standard, from interpreting the agreement and building the budget to tracking results, reporting and close-out. Participants work through multi-donor cases and leave with a Grant Compliance and Reporting Toolkit for a live or planned grant.

Course Objectives

- Interpret grant agreements and donor conditions and assess the organisation's readiness to manage restricted funding
- Apply logical framework, results-based management and internal control frameworks to funded projects
- Build grant budgets with appropriate cost recovery and track spending against them
- Prepare narrative and financial donor reports that meet donor templates, evidence requirements and deadlines
- Control grant risk, fraud and sub-grantee compliance, and prepare for donor audits and verifications
- Produce a Grant Compliance and Reporting Toolkit for a live or planned grant
