Introduction

Employees across every function now have access to chat assistants and office copilots, yet most use them sporadically, paste in data they should not share, or trust answers they have not checked. Organisations gain little productivity and carry new information and quality risks. This Core Concept course builds the everyday competence to use generative AI safely and well at work, from understanding how the tools produce answers to verifying their output. Every day is hands-on with realistic work tasks, and participants leave with a Personal Generative AI Workflow Playbook for their own role.

Course Objectives

- Explain in plain terms how generative AI tools produce answers and why they can be wrong
- Apply the organisation's acceptable use rules to decide which tasks and data may be used with which tool
- Write structured prompts that produce usable drafts, summaries and analyses on the first or second attempt
- Use chat assistants and office copilots to draft documents, summarise meetings and analyse spreadsheet data
- Verify AI output for accuracy, bias, confidentiality and attribution before it is used or shared
- Assemble a Personal Generative AI Workflow Playbook for recurring tasks in the participant's role

 - Analysts and officers who research, summarise and present information to managers
 - Customer-facing staff who answer enquiries and prepare written responses
 - Project and team support staff who track actions, schedules and status updates
