Introduction

Many organisations entering Saudi Arabia's King Abdulaziz Quality Award KAQA submit a polished document with thin evidence, so assessors find approaches that are not deployed and results without trends, targets or comparisons. Leadership time goes into the submission rather than into the improvements it should reveal. This course equips executives to sponsor an institutional excellence programme, judge readiness against the KAQA Excellence Model alongside EFQM and Baldrige, and govern a credible KAQA submission. Participants analyse submissions and feedback reports from several sectors and leave with a KAQA Readiness Assessment and Submission Roadmap for their own organisation.

Course Objectives

- Evaluate the organisation's excellence maturity against the KAQA Excellence Model, the EFQM Model 2025 and the Baldrige Excellence Framework using structured self-assessment evidence
- Interpret KAQA criteria, sector categories, award levels and assessor conventions to decide whether, when and at which level to apply
- Direct the preparation of a KAQA submission, from the organisation overview to enabler narratives and results evidence
- Challenge results data for trends, targets, comparisons and segmentation before it reaches assessors
- Prepare the executive team for KAQA site visits and convert assessor feedback into owned improvement priorities
- Approve a KAQA Readiness Assessment and Submission Roadmap with clear ownership and timelines

This Core Concept course moves from the KAQA landscape and the business case for applying, through the KAQA, EFQM and Baldrige scoring logic, to the governance of submissions, site visits and feedback. The final day turns that material into a KAQA Readiness Assessment and Submission Roadmap, giving executives a defensible basis for deciding when to apply and what must improve first.
