### Introduction

When contractors reach a tender list without proper checks, the consequences surface later as failed projects, safety incidents, insolvencies mid-contract and compliance breaches deep in the supply chain. Prequalification is often a paper exercise, classification bands are out of date and certificates expire unnoticed. This Core Concept course equips staff to assess contractors on financial, technical, safety, quality and integrity evidence, assign them to classification bands and keep them compliant after approval. Using cases from several sectors, participants produce a Contractor Prequalification and Compliance Framework for a contract category in their own organisation.

### Course Objectives

- Design a prequalification process with pass or fail gates and scored criteria in proportion to contract value and risk
- Assess contractor financial capacity, technical capability and safety, environmental and quality systems from submitted evidence
- Assign contractors to classification bands by work field, grade and financial capacity, and maintain the approved contractor list
- Carry out supply-chain compliance due diligence covering bribery, sanctions, beneficial ownership, labour and environmental requirements
- Monitor ongoing compliance through certificate tracking, audits, performance scores and requalification triggers
- Produce a Contractor Prequalification and Compliance Framework ready for adoption

The final day applies that method to a real contract category, and participants return with a Contractor Prequalification and Compliance Framework that makes approval decisions consistent, documented and defensible.
