Introduction

Local content now shapes who wins government contracts in Saudi Arabia. The Local Content and Government Procurement Authority LCGPA applies price preferences, a Mandatory List of national products, local content weighting in financial evaluation and minimum local content requirements. Sales teams that treat these as paperwork lose tenders on evaluated price, are excluded for missing evidence or face penalties after award. This course gives sales, bid and pricing staff the working knowledge to recognise each mechanism in a tender, calculate its effect and document compliance. Participants build and test a Local Content Bid Compliance Model using sample tenders.

Course Objectives

- Identify which LCGPA local content mechanisms apply to a tender from its conditions and specifications booklet
- Calculate evaluated prices under the 10% national product price preference and the SME and listed-company preferences
- Explain how the local content certificate baseline and target scores feed local content weighting in financial evaluation
- Check bills of quantities against the LCGPA Mandatory List and prepare exemption or substitution evidence
- Track post-award local content obligations and the evidence needed to avoid contractual penalties
- Build a Local Content Bid Compliance Model the bid team can reuse on future tenders

 - Pricing and estimating staff who build financial offers and bills of quantities

The final day produces a Local Content Bid Compliance Model that lets sales and bid teams calculate the evaluated price, check Mandatory List compliance and document evidence consistently on every tender they pursue.
