Introduction:

Digital library management has become the main workload of most libraries, yet many still run e-books, e-journals and databases through scattered spreadsheets, renew packages without usage evidence and leave users facing broken links and login barriers. This Core Concept course equips library practitioners to plan an e-library service, license and activate electronic collections, describe them with sound metadata, configure discovery and access, and evaluate value with standard usage reports. Participants work hands-on in library system labs and leave with a Digital Library Service and E-Resources Plan.

Course Objectives:

- Assess the current e-library service, subscription portfolio and user needs to set the scope of a digital library service
- Apply the TERMS lifecycle to manage e-resources from investigation and licensing through renewal, cancellation and preservation
- Create and map bibliographic metadata for electronic collections using MARC 21, Dublin Core and RDA practice
- Configure knowledge base activations, link resolver targets, discovery display and user authentication so licensed content is reachable
- Evaluate e-resource value with COUNTER Release 5.1 reports and cost-per-use evidence to support renewal decisions
- Produce a Digital Library Service and E-Resources Plan covering collections, licences, systems and user services

- Staff responsible for selecting, acquiring and renewing e-books, e-journals and databases
 - Staff who catalogue and maintain metadata for electronic and digitised library collections
 - Library systems staff who administer library management systems, discovery layers and access routes
 - Staff who deliver reference, research support and information literacy sessions to library users
 - Information centre coordinators in government, corporate and research organisations who run a small e-library

- Negotiate renewals with evidence by reading COUNTER reports and cost-per-use figures correctly
- Compare e-library practice with peers from universities, research bodies, government and corporate libraries across several countries

Conclusion:

An e-library serves its users only when licensed content is well described, easy to discover, reachable from anywhere and renewed on evidence. The course moves from service planning and the current-state audit, through the TERMS lifecycle, library metadata standards and systems architecture, to acquisition models, licence review, activation, discovery and authentication, and then to usage evaluation, access failures, perpetual access and digitisation choices. The final day's labs and case work turn this into a Digital Library Service and E-Resources Plan for each participant's library.
