Introduction:

New infrastructure, energy, mining and industrial projects stall or lose financing when their Environmental and Social Impact Assessment ESIA misses key receptors, rates significance inconsistently or produces a management plan nobody can implement. Weak baselines and late stakeholder consultation then surface as permitting delays, community grievances and lender conditions. This Core Concept course takes practitioners through the full ESIA cycle, from screening and scoping to baseline studies, impact significance, mitigation and the environmental and social management plan. Participants review a real ESIA and produce an ESIA Review Report and ESMP Gap Register.

Course Objectives:

- Screen and scope a proposed project, defining its area of influence, alternatives, valued receptors and the terms of reference for the ESIA
- Plan environmental and social baseline studies and judge whether existing baseline data is adequate for impact prediction
- Identify and rate impacts using a documented significance method, including cumulative and associated facility impacts
- Apply the mitigation hierarchy and translate residual impacts into an environmental and social management plan with owners, budgets and monitoring indicators
- Design stakeholder engagement, consultation and grievance arrangements for affected communities and vulnerable groups
- Review an ESIA report for adequacy against lender expectations described in the IFC Performance Standards and the Equator Principles

- Environmental and social specialists who prepare or coordinate impact assessments for new projects
 - Project development managers accountable for permits, approvals and financing conditions
 - Lender and investor environmental and social reviewers responsible for project due diligence
 - Assessment consultants who lead baseline studies, specialist inputs and report drafting
 - Permitting and review officers who evaluate submitted impact assessment reports

Conclusion:

This course moves from screening, scoping and alternatives, through baseline studies, impact significance and the mitigation hierarchy, to social impact assessment, consultation, grievance arrangements and the ESMP. The final day applies these methods to multi-sector case material and produces an ESIA Review Report and ESMP Gap Register that participants can use when preparing, commissioning or reviewing their next impact assessment.
