Introduction:

Legal English errors cost legal teams more than style points: a misused modal verb turns a duty into an option, a false friend misstates a ruling, and a literal translation imports a concept the other legal system does not recognise. This Core Concept course builds legal English and legal drafting skills for Arabic-speaking legal professionals, working on the language of contracts, judgments, memos and letters rather than on the underlying law. Participants analyse and rewrite real legal texts and leave with a Personal Legal English Toolkit: a bilingual Arabic-English legal glossary, a drafting style sheet and correspondence templates.

Course Objectives:

- Use legal English terms of art, Latin expressions and doublets accurately and avoid false friends common to Arabic-speaking lawyers
- Analyse the language of each part of an English-language contract and identify ambiguity in its wording
- Draft obligations, permissions, prohibitions and conditions with the correct modal verb and in plain legal English
- Read and summarise English judgments, legislation and agreements into accurate case notes and document summaries
- Write English legal memos, letters of advice and correspondence with opposing counsel in the appropriate register
- Translate legal concepts between Arabic and English, handling non-equivalent terms and building a bilingual legal glossary

Target Audience:

- Practising lawyers who advise clients on matters documented or negotiated in English
 - In-house legal staff who review, mark up and correspond on English-language agreements
 - Legal advisers and legal researchers who read English legislation, judgments and legal commentary
 - Legal translators and interpreters who render legal texts between Arabic and English
 - Paralegals and legal assistants who prepare first drafts, summaries and letters in English
 - Compliance and company secretarial staff who draft English resolutions, notices and policies

Conclusion:

Precise legal English is a working skill that can be practised and checked, not a matter of fluency alone. This course moves from legal vocabulary, Latin expressions and false friends, through the language of each part of an English contract, to modal verbs and plain legal English, and then to reading judgments, writing memos and letters of advice. The final day applies this material to Arabic-English translation cases and produces a Personal Legal English Toolkit that participants use on their next English legal document.
